**ERRATA TO *BRIEF AMICI CURIAE* OF THE COMPETITIVE  
ENTERPRISE INSTITUTE, *ET AL.*, IN SUPPORT OF PETITION FOR A  
WRIT OF MANDAMUS TO ENFORCE THIS COURT'S MANDATE**

In their brief *amici curiae* filed on July 19, the *amici* correctly noted in their Corporate Disclosure Statement that none of the *amici* is owned by a publicly-held entity or has members that issued shares or securities to the public. However, their Corporate Disclosure Statement mistakenly described what *kind* of non-profit one of the *amici* was. It described *one* of the *amici* – the Center for Individual Freedom – as a 501(c)(3) nonprofit corporation, when it is in fact a 501(c)(4) nonprofit corporation. Undersigned counsel regrets that error, which is his fault. The error involved a detail that was not even necessary to include in the Corporate Disclosure Statement to begin with, so it appears to be of no legal significance.
